Upcoming activities of the Nominating Committee include forming an ad-hoc committee to **recommend an AAHP representative for the ABMP**. Also, the Nominating Committee will be requesting input from the ABHP on their recommendations for potential candidate replacements for ABHP Board members. The committee will also solicit nominees from the ABMP, ABIH, CRCPD and other interested organizations. **One replacement board member is needed** to begin

a term in 2019. The Nominating Committee will ballot the nominees, and provide candidates to the Executive Committee prior to its meeting in Cleveland, Ohio in July 2018.

The Nominating Committee is also working with the Chair, Professional Standards and Ethics Committee to identify potential nominees for the **Joyce P. Davis Memorial Award**. Nominations are due to the Nominating Committee by 16 February 2018. The Committee will provide any recommendations to the Professional Standards and Ethics Committee Chair by 01 March 2018.

## THE FUNCTIONS OF THE PROFESSIONAL STANDARDS AND ETHICS COMMITTEE

The primary function of the Professional Standards and Ethics Committee is to **review any allegation** that a CHP has not adhered to the standards of behavior expected of CHPs. These standards can be found in Item 11 of the AAHP bylaws, and all CHPs should be familiar with them.

It is a credit to our membership that only rarely in its history has the committee actually been called upon to perform this function. Consequently, most of the routine work of the committee consists of regular review and maintenance of the standard operating procedures that have been established for handling any complaints related to ethical practice.

The other important function of the committee is to **review nominees** for the **Joyce P. Davis Award** and select the winner (subject to final approval by the AAHP Awards Committee). To quote from the AAHP webpage,

*“The recipient of this award demonstrates (the) extraordinary qualities exemplified by Joyce P. Davis, distinguishing themselves for excellence in professional achievement as well as being admired for ethical behavior and interpersonal skills.”*
